

The Tenders will be opened on **18. 09. 2014** at 11.30 hours, in presence of tenderers who may wish to be present on opening. 

Terms and conditions

- (I) The tenders should be sent by registered post or can be delivered personally at State Crime Branch Hqr's. J&K, Srinagar. (Near P/S Rajbagh.) The tenders received after expiry of prescribed date & time will not be entertained, no telegraphic/conditional tender will be accepted.
- (II) The rates should be quoted only for the items, specified in the list. The rates quoted for items other than the tendered ones will not be accepted. The **Brand/make/model /Warranty period** should be mentioned against each item quoted for supply.
- (III) The rates quoted should not be higher than the printed rate (MRP) market rates, however, Levis, freight charges, entry tax, carriages, insurance and duties if any upto **CPH Store, State Crime Branch Hqrs. J&K, Rajbagh Srinagar/ Panjthirti Jammu**, should be shown calculated separately.
- (IV) The tender should be filled typed or computerized print. Tender filled in by pen or Pencil or otherwise shall not be considered. No overwriting is acceptable.
- (V) The Tenderer shall be responsible for the proper packing so as to avoid any damage under normal condition of transport by Rail, Road or Air during delivery of the item at destination. In the event of any loss, damage, breakage or any shortage, the tenderer shall be liable to make good such loss and shortage found at the checking/survey of item. No extra cost on such account be admissible.
- (VI) The tenderer, whose tender is accepted shall arrange the supply within a period of 15 days from the date of placing supply order.
- (VII) The rates quoted will remain valid till 31.03.2015 and no increase in rates in any case shall be entertained. The Bank charges will be borne by the concerned firm. No advance payment will be made.
- (VIII) 100% payment will be made by W.D.C bill or Bank draft, if so desired after the supplies are received in full, duly surveyed, and accepted by the survey committee nominated for the purpose. Out dated/defective items will be rejected forthwith.
- (IX) The tender document must be accompany with earnest money of Rs.15,000/- in shape of CDR/FDR from any Nationalized bank pledged to **The Staff officer to Inspector General of Police Crime Branch J&K**, without earnest money the tender will not be accepted. The firm, exempted for furnishing earnest money, must enclose the requisite Certificate in support of it.
- (X) The tender fees have been fixed as Rs.500/-(five hundred) should accompany with tender offer in shape of a crossed demand draft favouring "The Staff Officer to Inspector General of Police, Crime Branch Hqrs.J&K ". The tender fee is non-refundable and the same will be deposited in the Govt. treasury under head-0055 Pol. as tender fee for the year 2014-15.The tender offer will not be considered without tender fees.
- (XI) The successful tenderer shall have to enter into an agreement in the prescribed form with the department. The contract shall remain valid upto the warranty period of the supplied item. The successful tenderer if fails /delay. to supply the material the earnest money of the concerned firm/ dealer will the forfeited
- (XII) The document for being an authorised dealer / reputed supplier be enclosed with the quotations. Literature/ original catalogue should be furnished with the equipment/material wherever applicable.


